1. WELCOME

The Chairman opened the meeting at 9.30 am. The Chairman welcomed all the members of the committee and thanked them for their attendance.

4. CONFIRMATION OF PREVIOUS MINUTES

The minutes of the previous meeting were confirmed.

- 5. BUSINESS ARISING FROM PREVIOUS MINUTES NOT COVERED ELSEWHERE
- 5.1 Government Relations

It was agreed that the previously agreed seminar for the Queensland Government should still proceed. While the format is still to be determined, the seminar would be a half to a full day covering use of and access to the resources of QUESTNet, AARNet, and the Internet. Specifically, topics should include the following: (1) gopher, (2) email, (3) VAT, (4) IMM, (5) Network News, (6) Library databases (7) Security, (8) Geoff Huston's AARNet Overview. A display and demonstrations should also be organised. Shelley Schmidt indicated that indicative numbers of two people for each of the 18 departments would imply 36 attendees. It was also felt that each attendee should be given a copy of the Internet User's Guide.

5.2 AARNet Disaster Recovery/Backup

5.5 QUESTNet/AARNet Relationship

This issue of regionalisation is being further considered and refined by the AARNet Board of Management. Alan Coulter had previously written to the AARNet Board on behalf of QUESTNet. John Noad has been requested by the AARNet Board to further refine the AARNet position for consideration by the Board.

Action: John Noad to keep members informed on developments in this area.

5.6 AARNet Affiliate Membership

Lengthy discussion took place on this topic. Specifically, there was confusion regarding whether potential affiliates are required to contact AARNet directly and become an affiliate member or merely to "purchase" an account on a network machine from an institution and thereby have automatic access to AARNet resources without the need to become an AARNet affiliate.

On advice from Geoff Huston, it appears that external organisations are not necessarily required to become affiliates. They merely need to acquire, from an institution, an account on a machine that has AARNet access. Further, if they are unsuccessful in acquiring such an account, they still don't need a "sponsoring" institution to support their AARNet affiliate application; they merely apply directly to AARNet.

Members felt that this area needed further formal clarification and documentation.

Action: Geoff Huston to request Peter Saalmans to document and distribute policies and procedures associated with the Affiliate Membership Program to help and quide institutions in dealing with potential Holling report.

6/7.AARNET DEVELOPMENTS

John Noad had attended the AARNet Board of Management meeting held in Sydney on Wednesday 1 September and was able to brief the meeting on latest developments. To support his verbal report, John tabled supporting documents. Geoff Huston also provided detailed background to the developments.

6.1 Microwave Rationalisation

The microwave rationalisation proposal was unanimously accepted by the Board. The Qld component of the proposal involves the installation of 34 Mbps link between the Brisbane institutions with two remote links to USQ and Bond (2 x 2 Mbps) using existing inter-campus links of UQ and GU respectively. Implementation time scales are of the order of 8-9 months. AARNet need to now develop a detailed engineering plan. Therefore, it is now necessary for the Qld universities affected to meet to consider in detail the technical and implementation issues involved in preparation for later design meetings with Geoff Huston.

Action: Graham Rees to convene a technical planning session involving the relevant personnel from UQ, QUT, GU, Bond, and USQ as soon as possible.

6.2 Other Qld links

Because of the distances involved, microwave was not a feasible option for JCU and UCQ. The most cost effective way of providing the required bandwidth is using Telecom's Fastpac 2 services. These services will be introduced in parallel with the microwave proposals.

6.3 Charging Structures for AARNet

Geoff Huston spoke to his paper that was presented to the AARNet Board. The Board requested Geoff to develop further the option of charging for total volume in and out of individual institutions. The option recognises the different cost of transmitting data nationally and internationally. It is likely that trial billing to institutions based on this model could commence in March 1994.

8. SECURITY EMERGENCY RESPONSE TEAM

It was reported that the AARNet Board of Management saw that SERT's role was clearly its responsibility. Further, to professionally proceed with the establishment of such a body under its responsibility, it should go to tender. Accordingly, AARNet are in the process of developing a tender specification. It is likely that the tender will only be open to Universities and CSIRO. It is hoped that the tender will be resolved by the end of the year.

Geoff Huston indicated that he didn't see any problem with the CAUDIT resolution that CAUDIT members would provide funds to help with the operation of SERT until the end of 1993.

9. GOVERNMENT INFORMATION TECHNOLOGY CONTRACT (GITC)

Colin Clapper (Manager, GITC Services, Administrative Services Department, Qld Government, and Chair, National GITC Working

Party) and Warren Tealby (Associate Director, Computing Services, QUT) attended the meeting to lead discussions on this topic.

Colin spoke at length outlining the history and development of the national GITC initiative that commenced in 1989. GITC has been developed and revised in close consultation with State and Federal Government bodies and industry involving IT specialists, purchasing, and legal representatives. Unfortunately, the University sector has not been involved with developments to date.

GITC has some underlying principles as follows: (1) all government should (not must) use GITC, (2) GITC should be used consistently across all areas, (3) Government should be considered as one customer (but special discounts under special conditions are allowed), and (4) suppliers must be GITC signatories before the Government will do business with them.

It was noted that all new Federal Government PE contracts will be GITC based.

GITC is the most advanced in Qld and it is now part of the State Government's Purchasing Policy. Suppliers have offered their BEST price and that price must be made available across all Qld Government (provisions include discounts for early payment, volume discounts, etc). In Qld, Govt departments MUST procure under GITC unless an exemption is sought and approved. It is unclear if this mandatory requirement applies to Universities. There are over 200 signatories to GITC covering most of the IT industry except packaged software.

In August 1993, a new draft document was released for comment with revised format and comment. This document will be considered by the full working party in November 93 for final release Q1 1994.

The major initial concern for suppliers (and continuing concern for small suppliers) is the requirement to conform to quality standards. For universities, the concern is that while there may be many benefits that flow on to universities as a result of GITC, some suppliers are indicating that special education discounts will no longer apply because the supplier would be required to supply all Government at the University discounted price. This twist is certainly an unintended disadvantage to universities.

Another important issue associated with GITC is when universities are suppliers of services to Government (e.g., consulting, training). It appears that, for such situations, universities would be treated the same as any other government supplier and would need to become GITC signatories before they could supply (or continue to supply) services to Government.

As a result of the lengthy and useful discussion, the general thrust of which is captured above, the following main issues emerged:

- =98 GITC should not drive prices UP for Universities;
- =98 Universities should still have the freedom to acquire outside GITC; and =20
- =98 What are the requirements and how should universities best address such requirements regarding GITC when they are suppliers of services to Government? =20

Action: Warren Tealby to represent QUESTNet on the National GITC Working Party.

Action: Members to nominate a representative from their institution to liaise with Warren regarding on-going discussion with Col Clapper and input to the GITC Working Party.

10. DIAL-IN QUESTNET ACCESS

Alan McMeekin introduced this topic. He indicated that, of the 14,000 students of USQ, 9,000 were external of which 25% were from the Brisbane and Gold Coast region. He would like to see QUESTNet develop a policy whereby such students could dial-in to facilities at USQ via a local call to modem-banks at UQ, QUT, or GU. It was agreed that Alan should contact the relevant institution directly to make specific arrangements. However, further discussion resolved that:

- =98 a charge of \$50 per semester per student should be levied for students to have a dial-up privilege. This would include the establishment of a captive account that would automatically route the student to the intended institution.

- a charge of \$300 per annum per client should be levied for external clients to have a dial-up privilege. This would only allow clients to access services for which no account was required (e.g., Library catalogue; ??????? shouldn't we ask the Librarians first??)

11. QUESTNET'93 WINTER WORKSHOP REPORT

Ian Jenkins distributed and spoke to a written report to members prepared by Merv Connell regarding the QUESTNet'93 workshop. While the accounts are not yet finalised, it appears that the workshop produced a modest surplus.

Members who attended the workshop indicated that it was very successful and valuable to participants. The committee expressed its appreciation to UCQ and the organising committee for its efforts in organising a successful workshop.

The issue of surplus funds was discussed and it was resolved that any surplus funds should be held at one location and used for QUESTNet-related activities such as the up-coming seminar.

12(a) Systems Programmers' Workshop

It was felt that there was still a need for a strictly technical forum where the technologists could gather to discuss common technical issues and concerns. It was agreed that such a workshop should be arranged for the '94 Easter period.

Action: Ian Hunter to organise a strictly technical workshop for systems (and network?) programmers to be held in the March/April '94 period.

13. SUPERCOMPUTING

John Noad reported on the current status of the Mechanism C MPP supercomputer project.

The tender specification (the first draft of which was prepared by Coulter, Noad, and Dengate) has been refined by the Joint Committee and, he understands, will be made available to industry today with tenders to close on October 1. The funds (\$1.4M) have to be committed by the end of 1993.

An initial meeting to develop an Operational Management Agreement has been held but a draft Agreement has not yet been made available for comment.

14. BROADBAND NETWORKS

Alan Coulter briefly spoke to the options for medium to longer term technologies. He undertook to prepare and distribute a discussion paper on this issue.

Action: Alan Coulter to distribute a discussion paper on Broadband Networks. =20

15. OTHER BUSINESS

Geoff Huston advised that the email fax trial will be terminated on Monday 6 September.

16. NEXT MEETING

The timing of the next meeting to coincide with the proposed seminar for State Government. The date for the seminar is still to be determined but will most likely be in November. Members will be advised.
