# INTERACTIVE VOICE RESPONSE SYSTEM FOR QTAC

AS part of a new computerised Admissions System for the Queensland Tertiary Admissions Centre (QTAC) being implemented by Prentice Centre staff from the Applications Development Group, applicants are now able to ring in and clarify their application status, using the Interactive Voice Response System (IVRS).

The IVRS enables applicants to query their application status and alter their preferred courses by simply using a standard touch tone telephone.

The system is being implemented by QTAC staff as part of a new computerised Admissions System in its final stages of development by Prentice Centre staff. The project has provided staff with considerable challenges as it embraces the latest client server technologies running a rule-based application in an X-Windows presentation environment.

It has been specially designed to incorporate a flexible profile-based approach in the selection of applicants to tertiary institutions in Queensland.

The profile-based approach ensures that every relevant facet of an applicant's background, from study to work experience, is considered by assessors using the system to allocate a place to an applicant.

## DO YOU QUALIFY AS AN 'ELECTRICAL WORKER'?

CCUPATIONAL Health & Safety Unit Director, Barry Pratt, has advised that the Electricity and Workplace Health & Safety Acts require all electrical work to be carried out by an 'electrical worker'.

In addition, an electrical worker is defined as an electrical tradesperson (i.e. electrician), electrical engineer or individual with a restricted certificate.

Following on from this, Prentice Centre's Director Alan Coulter urged staff of the University to ensure that they did not tamper with electrical components unless they were fully qualified.

"Even something as seemingly harmless as removing covers from electrical appliances such as personal computers or audio visual equipment thus exposing the electrical components, constituted 'electrical work'", Alan Coulter said.

"Under these circumstances, staff should be aware that a violation of both the Electricity and the Workplace Health & Safety Acts may be committed if they are not qualified to do the job," he said.

## Minimum monthly charges

PRIVATE users of UQVAX and Brolga systems are advised that effective February 1993, the minimum monthly charge of \$20 which applied up to and including 1991, will be reintroduced.

As before, the fee will NOT apply to users within University of Queensland departments or sections, but WILL affect external organisations and pri-

vate individuals who have been granted access to these systems and whose computing use amounts to less than \$20 per month.

This minimum monthly fee was waived for 1992 during the transition to a new project accounting system.

Reintroduction of the fee is necessary to cover administrative overheads associated with these user accounts.


